For the Work to be accepted for publication, this agreement must be signed and returned by:

The Author, desiring to publish the Work in ESC! Magazine, hereby grants to Michael R. Potter (the "Publisher") non-exclusive, worldwide print and/or electronic publishing rights in either whole, excerpt or summary form, of the Work. Author gives consent to Publisher to maintain the Work in an online and print archive of past issues of ESC! Magazine.

In exchange for these rights, Author acknowledges full compensation through the receipt of ___ contributor cop(ies) of the issue in which the Author is published. All efforts will be put forth by the Publisher to mail these copies to the Author no more than 2 - 4 weeks after the initial date of publication. Completion of this agreement does not obligate the Publisher to publish the Work should any unforeseen circumstances arise which would prevent the Work from being published or otherwise distributed. In the event of such circumstances, the Publisher may opt to select the Work for inclusion in a subsequent issue of ESC! Magazine under the terms of this agreement.

Author retains all intellectual property rights to the Work and reserves all rights not specifically granted to the Publisher herein including the right to reprint the Work in any manner or form following publication in ESC! Magazine. Author agrees to make a good faith effort to include proper credit to ESC! Magazine for first publication of the Work, including date (month and year) and/or issue number of ESC! Magazine within which the Work was published.

Author warrants that the Work is original except for excerpts from previously published works which fall within the bounds of fair use or for which permission to include has been secured from the copyright owners thereof; that it contains no matter which is libelous, unlawful or which infringes upon anyone's proprietary rights, including, but not limited to statutory or common law copyright; that it does not violate any right of privacy; and that the Author is the sole Author and proprietor of said Work and the sole owner of all the rights granted to Publisher, and has full power to enter into this Agreement. Author agrees to indemnify and hold harmless Publisher, its successors, agents and licensees, from any and all claims and causes of action of any kind or nature whatsoever based upon the use of the Work as submitted.

Author acknowledges the right of the Publisher to edit wording, grammar, spelling, and punctuation as necessary.

This Agreement contains the entire agreement of the parties with respect to the subject matter hereof and shall not be amended except by a written agreement subsequent to the Effective Date and signed by authorized representatives of each party. You shall not assign, transfer or sublicense this Agreement (or any right granted herein) without the prior written consent of the Publisher. All questions arising out of this Agreement shall be construed and governed by the laws of the State of Illinois.

The Publisher reserves the right to obtain additional rights to select and republish the Work as part of future anthology collections. Compensation for additional rights will be negotiated and agreed to by the Publisher and the Author of the Work in a subsequent document agreed to and signed by both parties.

Author acknowledges he/she is 18 years of age or older. Authors under 18 years of age must obtain written permission from a parent or legal guardian before completing and mailing back this agreement.

YOUR DISTRIBUTION RIGHTS

a) PDF COPIES

4. You may not charge a fee for the PDF copy of ESC! Magazine or for costs incurred as a result of distribution.

b) SELF-PRINTED COPIES

You may not distribute printed copies of ESC! Magazine for a profit above the suggested list price printed on the cover. 3. By distributing self-printed copies of the issue in which your Work appears, you agree to the following conditions:

 - b. Copies 11+. You must pay a reprint fee of 0.75 US Dollars (seventy-five cents) to Michael R. Potter for each self-printed copy of the issue in which your Work appears. Payment must be made by personal check, cashier's check, money order, PayPal or other form as designated by Michael R. Potter. Payment must be made in US Dollars.

c) WHOLESALE COPIES

1. You may purchase printed copies of ESC! Magazine for resale directly from Michael R. Potter at a special contributor discount price (wholesale) plus shipping.
2. You may not resell copies of ESC! Magazine for more than the listed cover price.
